



From The Commodore

I take this opportunity to thank all Royal Yacht Club of Victoria Members for their resolute commitment and support of the Club through a year of significant difference and challenge. So much of what has transpired has been beyond our control.

It is with great pleasure to note that throughout this time of fragmented opportunity for sailing and social activity, Member response to participate when permitted has been exceptional. The Club is now at its highest level of recorded membership, and it is not uncommon for the dining room or deck to be fully booked supporting the new food and beverage service.

The Royal Yacht Club of Victoria Strategic Plan is currently being reviewed. Diversity, inclusivity, youth and broad community engagement are priority issues being addressed. The aim is to become the sailing club of choice in our western region and to be known for welcoming active community engagement. The Strategic Plan must ensure the Club is relevant for the future. It must also offer a progressive and achievable roadmap for the next General Committee to follow and further develop the priority issues.

At the same time, the Club is facing several challenges in relation to ageing infrastructure as most Members appreciate. The issues are being assessed in terms of risk, priority and affordability. An Infrastructure Re-development Plan and Capital Expenditure Plan will, in the near future, be presented for Members' consideration. The bathroom renovations were unfortunately delayed but are now being priced.

On behalf of the Club, I thank members of the General Committee for their unwavering commitment, effort and prudence in 'charting a course through difficult waters' during the last 12 months. General Committee has worked cohesively and productively during a period of significant challenge including the COVID pandemic, infrastructure challenges and other matters. The Chairs of each Sub-Committee have

prepared detailed reports for each of the Club departments.

On behalf of the Club, I thank all Sub-committee members for their tireless work and commitment to the activities of their areas of responsibility. The Club is now enjoying the benefits of a very collaborative and interrelated Sub-Committee structure, supporting each other with integrated expertise.

In the July eNews 'Commodore's Message to Members', I stated that volunteers offer an invaluable support group without which our Club could not exist. It is not only that regattas and events could not be held, Club management would not function and provide the services to Members it does at affordable levels. Our Club is volunteer based and reliant both on the water and off the water. Royal Yacht Club of Victoria volunteers are very special people and the Club sincerely thanks all its volunteers.

While I do not like to single out individual Members, it is fitting that we acknowledge the advice, effort and leadership given by Steve Standen in completing the levelling of the traverser pit, the rehabilitation of the railed yard and repair works to the travel lift. Thank you to Steve and his teams.

I also thank all Members who have contributed to the Club in different ways throughout the year.

Please consider becoming a volunteer. You will be most welcome!

Thank you to General Manager Michael Neumann and the Club staff for working so well through the impositions that have been applied during the working year.

The various COVID shutdowns have been very challenging to all and particularly so in relation to the Club's financial sustainability. As a result, the Club has recorded a loss of \$45,537 in this past



RYCV Strategic Plan Review

Over the past year, I have been working on a review of the Club's current Strategic Plan on behalf of Commodore Doug Shields, with the assistance of General Committee members. We created a small working group comprised of Paige Butcher, Warwick Norman and Ian Barclay to map out the process and agree on the tools we would use including an environmental scan using the PESTEL framework (political, economic, social, technology, environment and legal) as well as a SWOT Analysis (strengths, weaknesses, opportunities, and threats). We then held a General Committee planning day on Sunday 2 May, 2021. Given the COVID Safe density restrictions at that time, the Royal Motor Yacht Club generously allowed us to use their facilities free of charge so that we were able to avoid impacting Member access to our own Club.

At the planning day, Commodore Doug kicked the day off with a presentation to set the scene for the day's work including reasserting our vision. mission and values. Paige Butcher led a session to review our progress to date against our current strategic plan and targets. I then ran a workshop to undertake an environmental scan and another session to produce a SWOT analysis. The morning's work was then used to inform Warwick Norman's session to review our current strategic priorities; had they been completed, were they still relevant, what was missing? Rear Commodore Club, Tim Olding then took us through a deep dive into the Club's infrastructure and facilities development plan and discussion of priorities for investment and capital planning.

The working group put a lot of work into preparations for the planning day, which contributed to the day's successful outcomes including developing a good understanding of the broader context in which the Club operates, recognising our achievements to date and where we need to do further work, and where we need to prioritise our future efforts and investment. It is very clear that given our aging infrastructure, facilities and associated risks, a major priority going forward is to invest in the Club's facilities strategically and prudently.

The next steps are to introduce the draft plan to the Club Membership at the 2021 Annual General Meeting and to engage the membership in



providing input and feedback over the coming months with the aim to have a final strategy ready for endorsement at the next Half Yearly General Meeting.

I wish to thank the General Committee and Chairs of the Club's Sub-committees for their contribution to the review and planning day, and I would like to particularly acknowledge the contribution of the working group - Paige, Warwick and Ian.

I look forward to your feedback on the draft plan to ensure that we are meeting the needs of our Members and to develop strong support for the final plan.

Congratulations to all our Members who participated and persisted with the 2020-21 Sailing Season. My predecessor, and now Vice Commodore, Jane Richards observed in last year's Annual Report that the 2019-20 sailing season was "very strange". The 2020-21 sailing season continued that trend. While 2019-20 was consistent in that sailing was limited, the 2020-21 season was even stranger in the sense that it was unpredictable, with sailing commencing then stopping with snap lockdowns put in place then lifted almost as quickly. This played havoc with planning in all aspects of Club operations, particularly sailing. The season commenced in muted tones with a very low key and delayed Opening Day. The COVID restrictions in place allowed for limited sailing which was confined to Wednesday twilight racing fun from the marina box. As restrictions further lifted, more of the sailing program was completed. Off The Beach had an extended season running into mid-May to

get all the scheduled Club aggregates in. On the regatta front, all our major events were able to proceed. Even with the good management in place, this was only by good fortune in that no lockdowns were called when they were running. The immediate future for sailing everywhere in Port Phillip looks likely to continue along in the same way with intermittent COVID based lockdowns. Sailing Committee are now familiar with dealing with this and are able to adapt the sailing program accordingly.

2021 Club Racing Achievements

For this year, we have a very local flavour due to the cancellation or restrictions placed on interstate events. Results for RYCV sailors are as follows: Commodore In Chief Trophy Ray Borrett and crew on LAURELLE.

THIRSTY WORK skipped by Gary Fell won the Commodores Trophy and the Elwood Houn Trophy, well done to Gary, Marshall and Lindsay. The Phoenix Trophy wend to David Burton and crew on COROMANDEL 6.

Single handed racing proved to be very strong this year and the Black Bottle Trophy was taken out by Patrick Clark on TANDEKA.

Sunday racing was also well patronised with MAGIC skippered by Rick English winning the Tripe and Onion Series while SHORE THING. Robin Worland and crew, won the Steak and Mushrooms.

Morrow) and OASIS (Paul O'Driscoll). While we ultimately unsuccessful in winning the cup back, our sailors fought hard and placed 2nd in difficult, light conditions.

The top Royals boat was MERAK, 4th, skippered by PC Bas Huibers.

2021 National Noelex 25 & 30 Championship

For the second year in a row, we ran the Noelex National Championships. Run over 2 days in May (22nd to 23rd), we had much reduced COVID fleet of 7 boats.

During the latter part of the season, our Club hosted three high profile OTB regattas these were: **Musto Optimists state titles, School Teams**

State Championships and the Youth Sailing State Championships.

Lipton Cup Regatta was unfortunately cancelled this season. Planning is underway for running this important event this year.

This year, our Club has moved to a volunteer-based model which will continue to provide a **high standard of race management** for a range of sailing events and to further our strategic objective to enhance our reputation for hosting world-class international, national and state events. Our race committee undergoes regular training, accreditation and re-accreditation courses. Women in race management is also a key part of our strategic plan and this season we were able to secure funding for further training for women only. In addition to this, the Sailing Committee has setup training sessions on Sunday afternoon for anyone who would like to get involved in race management.

Port Phillip women's Championship Series

We hosted race 3 and 4 of the Port Phillip Women's Championship (Val Hodge Trophy). In a first for our Club, this round of the PPWC was run by an all women race committee of Allicia Rae and Amanda Rawstron.

Unfortunately, **Australian Women's Keelboat Regatta** was again unable to go ahead on the scheduled date of 11-14 June.

And finally, but not least, my thanks go to the Members of the Sailing Committee and the OTB Committee. Thanks also to our hardworking team of Staff - Michael, Allicia, Andy, Ian, David, Melissa, Camilla, Gary and Jenny. It has been a difficult six months and your resilience and continued dedication to the Club has been amazing.

There have been some staff changes on the sailing front with Allicia Rae leaving in April. A very heart felt thanks to Allicia for all her hard work.

Our long serving Race Director, David LeRoy, will be resigning in September after 20 plus years at RYCV. Thank you to David for all the work, week in week out, and for the mentoring role in developing the new race management team.

Most importantly, I wish to thank all of our amazing volunteers who contribute to our on-shore and off-shore activities - without you we would not be able to have such a great time out there on the water. There is a core of volunteers who turn up every week and for every regatta. Thank you to Amanda Rawstron, Steve Standen, Dennis Spindley, Wanda English, Ross Anderson and Duncan Rae.

It has been a very difficult and disrupted year with numerous challenges to overcome. On behalf of the Sailing Committee, I wish to acknowledge the obstacles we have all had to face. We have fought on and not only managed to get through this year but are wiser, more skilled and resilient than ever. Well done everybody and let's continue this into next season.

Committee

Since our last report, Steve Standen has elected to stand down the from the Committee and we thank Steve for all the work he has done in over the last 18 months. Guy Schofield has offered to join the Committee and will focus on undertaking a review of our Club vessels to ensure they are still suitable for the tasks they undertake; this will assist the Club in planning any potential upgrades or replacements of our Club boats.

Yard Personnel and Operations

Since the half yearly AGM, Max Leonard has moved down from CYCA and taken up leadership of the Waterfront team. Max's role includes managing the marina and yard bookings, overseeing yard operations and the maintenance of Club assets.

Max continues to be supported by Luke and Ben. We would like to thank them all for their flexibility as we have moved through the various lockdowns and other unscheduled events that have affected yard operations.

Through this year, yard operations have been not only affected by COVID restrictions but also unscheduled downtime due to ageing infrastructure and equipment failures. In the last 6 months, the yard has lost working days due to the following issues

- COVID lockdown, 24 days
- Travel lift breakdown, 13 days
- Bad weather, 4 days

As you can see, the travel lift is the second most significant cause of lost time in the yard. Each day of lost time represents lost revenue but more importantly it means that all our Members and the contractors, who support our Members, cannot reliably plan their working week. It is a crucial

piece of Club equipment as it is the only means for boats to be moved in and out of our yard.

The current travel lift is over 40 years old, and we are assessing the viability of maintaining an ageing asset vs the cost of replacement. In the last 6 months, the combination of lost time and unscheduled repair costs is between \$15,000 and \$25,000 depending on how we value the cost of a lost working day. This must be weighed against the cost of taking out a loan to buy a new machine.

We have begun gathering information on the cost of buying a new travel lift. It is between \$400,000 and \$500,000. A new machine would have the same or slightly higher lifting capacity, but we are still studying the best specifications. It would be preferable if the vard was able to fund the acquisition of a new travel lift through profits from operations. To achieve this, we need to increase the number of boats that we bring through the yard, so we have begun marketing the yard to boat owners up the river and at other marinas without lifting facilities. If we can increase turnover and profit with our existing machine, it will show we can fund a new machine. Our new temporary membership class allows us to bring outside boats into the yard without being in conflict with our lease terms. The extra yard space created by removing the rails allows us to increase overall turnover without compromising service to Members.

We are not yet looking to make a recommendation to Members on what we think is the correct path, but we expect that we will make a recommendation at the half yearly meeting.

Hardstand and Waterfront

As previously communicated, the waterfront infrastructure is showing its age. The travel lift fingers were recently taken out of commission for a few weeks due to concerns about the condition of the supporting piles. These have now been signed off by our engineering consultant, but the lifting capacity remains limited to 20 tonnes.

We have some time up our sleeve, but we will need to replace these piers sometime in the next two to five years. We have preliminary construction drawings for new piers and have started informal discussions with construction companies so we can determine the scale of the investment required. In a perfect world, new piers

would be coordinated with a new travel lift so we could increase the beam of boats lifted. This would only be viable if the combined cost of a travel lift and piers is within the Club's capacity to fund in one lump. The extra cost of increasing the lifting capacity must be weighed up against the extra revenue from services that it would generate. Matt Fahey is part way through a study that aims to understand the weight and beam of boats we currently service along with the weight and beam of new yachts coming onto the market.

Another area of concern is the concrete area and sea wall in front of the lawn. The concrete is showing signs of subsidence and failure of the reinforcing within the concrete. The sea wall also shows signs of decay and has developed a seaward lean. We have commissioned a design for a new retaining wall that would be placed in front of the existing wall, allowing the concrete to be removed and replaced. The cost of this exercise cannot be estimated until we have the drawings from our engineer.

Marina

Marina occupancy continues to be strong with 82% of berths under long term agreements. We replaced 11 broken piles in July bringing all of our berths into service but then we lost another pile in the recent storms.

As mentioned at the last half year General Meeting, we continue to look at options for upgrading and/or replacing the existing marina. Our current wooden structure requires continuous repair and maintenance and we remain committed to doing everything we can to keep it in the best condition possible. This is an expensive exercise; we have forecast more than \$100,000 in the next 12 months on repairs and maintenance and we do not expect this to decrease further into the future.

As mentioned, we lost another pile in the recent storms. Whenever this happens, we face the risk that a yacht will break free and cause further damage. We will aim to reduce this risk through continuous inspection and repair, but we would like to remind all boat owners of the importance that yachts are well secured with bow lines and springs that are fitted to minimise the load on the marina and your boat. If you believe you require new mooring lines, please contact our waterfront manager Max Leonard.

New Fixed Pile Marina

One option we have started to look at is the replacement of the existing marina with a new fixed pile structure made with steel piles and an aluminium superstructure. It could be built at approximately two thirds the cost of an equivalent floating marina and would not require a full depth wave and surge attenuator.

The money we invest each year in maintaining the existing structure may be better spent on loan and principal repayments on a new, low maintenance fixed pile structure. We plan to undertake a study, at no cost to the Club, into the viability of such a structure and compare the cost with a floating marina with full depth wave attenuation.

Requirements have been sent to an international marina construction company with experience in piled marinas. We are waiting for an indication of cost.

Ship Surge Study

The study of ship induced surge has ended its data collection phase and the results are being processed by GHD and the Department of Freight. We expect some findings by the end of this year. The findings of this study will also feed into the Williamstown Maritime Precinct Study that has been commissioned by the State Government.

Shiplift Hole Remediation

The new supporting strut has been placed in the ship lift hole and instrumentation has been fitted and calibrated. In August 2021, we removed the old steel brace and have begun monitoring the forces on the walls. We should be in a position to advise Members about what we can do with his structure by the half year General Meeting in February.

Capital Works Planning

The Club faces many demands on its funds to maintain and improve Club facilities. From this report, you can see that we need to prioritise investments and address some near-term issues to ensure all our key facilities are serviceable. Based on what we know right now, we believe the order of priority is:

- Continue to investigate options for replacing the existing marina
- Replace the travel lift fingers
- Replace the travel lift



- Repair the concrete apron and sea wall in front of the lawn
- Build new launching ramps and increase casual berthing along our waterfront
- Build new lockers and contractor workshops

In summary

This report illustrates that the Club is facing parallel demands for reinvestment in key infrastructure and assets that are fundamental to providing all services that a full-service keelboat club should offer. The current assets have worked long and hard but some of them are coming to the end of their practical life. We are committed to working through these issues and we will keep the membership informed of our findings and recommendations. House and Social Sub-Committee

What we thought was going to be a relatively normal year compared to 2020, has not been the case. Since reopening the Club's hospitality services in November 2020, we have endured a further 3 lockdowns, all having a significant impact on hospitality at the Club. For example, disrupting service levels, staff recruitment, retention and obviously financially on the bottom-line. Credit to Pete Evans (Food & Beverage Manager), the core team has remained loyal to the Club and shown a high standard of professionalism.

Further good news is that the new in-house model for running the food and beverage services has been a huge success for the Club. For example, Member satisfaction is up (Members' survey results indicated), patronage is up in all sectors, there is an increase in function activity and of course fantastic attendance at many of the social events held throughout the year.

Key Events

During the last year, the House and Social Committee have been involved with at least 20 events, some small to others being all day events. Once again, attendance and support from Members has been greatly appreciated.

The key events during the year included, Santa by Seaplane, New Years Eve Celebrations, Australia Day, Doggy Day Out, Mother's Day, Trivia Night, etc. We have also started up the Winter Night Series with guest speakers presenting on a wide range of topics and Meet the Maker (wine tasting with a 'master' of wine'). Doggy Day Out was by a long way our best trading day so far – Julie Standen was outstanding in her organisational skills, even recruiting the whole family to help, making the day a great success.

Our most popular and successful event we run regularly is the Friday Night Bar Draw. When there are no lockdowns or restrictions in place, we have had great support from Members participating in the fun on the night. Julie Standen, Megan Jackson, Eliza Mead, Steve Chittenden and Rene Seddon-Johnson run the nights making sure everyone is involved in the fun. The team also run a raffle on the night with heaps of prizes from our very generous sponsors - the proceeds from the raffles are determined by the House and Social Committee for an item that will benefit all Members, e.g., TV in the bar area, looking at new

couches for in front of the open fire or on the deck in summer.

In our recent Members' survey, it was noted that Members are wanting more social type activities. This has been acknowledged and we will be working even harder to fill this request.

We are looking forward to next year, hopefully with less lockdowns and restrictions so we can have even bigger and better events for Members to join in and be part of.

Food & Beverage Services

Like most hospitality venues in Melbourne during the COVID-19 lockdowns and restrictions, it has been difficult to operate in a normal manner both in our dining room and bar areas. Overall, most Members have respected the difficulties staff have had to endure and supported the endeavours in providing a much-improved food and beverage service, which has been greatly appreciated.

Pete has trained and developed a great team under him; they are professional, friendly and starting know and understand what individual Members' needs are, especially the regulars. There has been very little turnover of staff as well, which is a great sign of stability.

Although we were aiming for at least a financial breakeven position in Food & Beverage last year, the impact of COVID-19 has contributed to significant costs in labour to provide additional services and the fact of operating in a stop start mode has reduced revenue significantly.

The Club made the decision to still provide food and beverages at a reasonable price with a further Member discount; our pricing remains competitive compared to many other venues around Melbourne.

The Club has seen a big increase in enquiries and bookings for functions at the Club, for both Member and non-member private and corporate events. Hopefully next year we will be in a better position take on more and larger bookings.

Archives - Book Launch - Ann Goodwin

The Archives Sub-committee met on 20th February 2021. It was noted that a request was made to General Committee in August 2020 for an annual budget allocation towards Archives activities. The location for a replacement display cabinet to house historical Club Trophies remains under review and will be considered with the plan for overall development of the clubhouse interior.

There has been ongoing activity with writing the history of the Club. Two Members of the Archives Sub-committee have contributed their sailing stories to the book – Bern Case and Lindsay Butler, and David Robbie has assisted with proofreading the first draft. A prolonged phone conversation with Graeme West in December 2020 guided the author to investigate Club sailing activities in the 1960s and 1970s for inclusion in the book. An overview of the book 'Cast Your Eyes Astern' was presented at the launch of the Williamstown Literary Festival held at Royals clubhouse on 7th May 2021. There are plans to offer pre-sale orders and launch the book at a future Club event.

The Archives Sub-committee were pleased to receive a photo taken at the Centennial Regatta held by the RYCV in March 1954. This has been included on the book cover. One request for family history information entailed searching through Club newsletters produced in 1988. The COVID-19 travel distance restrictions have made it difficult to visit the Club and search through documents held in the storage container.

Sub-committee members are Lindsay Butler, Bern Case, Peter Miedecke, PC Bob McGregor, David Robbie, Ann Goodwin (chair). We have lost PC Graeme West (dec).

House Renovations - Charlie Salter

Honarary Architect Charlie Salter has been extremely busy over the past 12 months moving forward on several building projects around the Club. These include renovations of the clubhouse bathrooms and change rooms (including the office and administration areas), the enclosure of the deck area and new starting box on J Row. Unfortunately, COVID-19 has made the starting of these projects very difficult, for example the

shortage of suitable trades people, supply problems and extended lockdown periods. We are hoping to see all these projects commence over the next 12 months.

Conclusion

We are hoping that the next 12 months will not be a repeat of the past 2 years with continual disruption due to COVID-19, and House & Social Committee can do the work that we do best and start to provide ongoing social events in a safe and conducive space at the Club.

It the meantime we do greatly appreciate the support and understanding that Members have given us during these trying times.

Governance

In 2020, the Australian Institute of Sport (AIS) developed guiding principles for sporting associations. They thought that there was a need for educational and accessible principles to help guide organisations both large and small to good governance. Whilst good governance principles override all companies and associations, some of the differences include sport's

- Unique structure.
- Passion whereby experienced office members can make decisions with their hearts rather than their heads.
- There are long histories and traditions which can make change difficult.

During 2020, General Committee (GC) members have discussed the good governance sporting principles which have included:

- An understanding of governance including sports governance
- A value driven culture and behaviour
- A clear vision that informs strategy
- Diversity of committee members
- Rules and documents that outline duties, power, roles and responsibility
- Risk management including health and safety.
- Internal review processes
- Difference between operational activities and committee responsibilities.

This is an ongoing process. Each new committee member should have an induction to good governance in order to understand the responsibilities attached to the position to which they have been elected or nominated.

The health and safety of all Members and staff has been seriously considered during the year. The policies and procedures can be found on RYCV's website, including the Club's Code of Conduct which outlines expectations of behaviours. Members of GC and management expect all people involved with the Club to treat each other with dignity and respect. There have been occasions where the Code of Conduct has been breached requiring disciplinary action. Good governance ensures that there is a consistency of approach as to how breaches are dealt with.

We hope to continue working on good governance principles to ensure that the Club moves forward in a positive and healthy state.

Membership

The past membership year was defined by the health-emergency response to the COVID-19 pandemic. This posed ongoing challenges for the uninterrupted delivery of the full array of member services from our Club. Government financial relief packages implemented prior to the billing date for membership subscriptions meant we returned this as a direct benefit to Members through a 25% fee reduction and 4-month deferment to all membership categories. Importantly, our skilled Club staff were retained and, in some cases, redeployed to other duties. Success of the Victorian community in controlling the second wave outbreak in the winter and spring of 2020 meant that some benefits of Club membership in sailing and social activities could be delivered over the summer of the first year of the pandemic. We remarkably achieved a steady growth in RYCV membership during this period demonstrating the strong camaraderie and resilience of our sealoving Members.

Over the past year, the Membership Committee (MC) has persisted with a focus on building our membership base in line with the changes to the rules adopted at the 2019 AGM. On assessing the membership statistics from 2020 to 2021, we again achieved a healthy 12.6% rise in membership to a total of 993, but down on the 16% increase from the previous year. This is largely attributed to the ongoing benefits of the rule change increasing in the cap of Social Members to a maximum of 49% of our total membership. Social memberships increased by 34% over the year yet are only 35% of our total membership, and the sailing divisions making up 65% of our Members.

The success of Social memberships has been built on our dining and bar operations and the Club's facilities for outdoor dining on the deck and the lawn. The improved quality and value for money of the food and beverage offerings, together with a re-vamp of the dining facilities and options, outweighed the inconvenience imposed by the public health requirements for managing guest

registrations and social distancing. This has been a great achievement given the circumstances.

Our Social Members are a precious asset for the Club and the Membership Committee are working with the Sailing Committee to explore ways Social Members can begin to engage in sailing. A steadily increasing number of Social Members have upgraded to sailing memberships despite limited on-water activity over the past season. The Sail Training Academy, on-water volunteering and the SailPass scheme have all assisted Social Members in making this transition. But ultimately, it is the welcome and encouragement new sailors get from boat owners and their crews that is the most important factor. We thank all those who have helped in this regard. We look for more avenues to introduce Social Members to sailing.

One of the objectives for the Membership Committee is to encourage a reduction in the average age of our membership. Younger Members are needed to ensure the ongoing longevity and future prosperity of our Club. The average ages of Social and Sailing Members are now about the same (55.8 / 55.6yo) but the average age of our Members has increased this year from 54.4 to 55.6yo.

This resulted from a 34% reduction in Junior Members and a 71% reduction in Junior Family Members that has led to the increase in our average age of membership. The loss of Junior Members and younger family members in junior sailing was coincidental with the time of behavioural issues in the Off The Beach section and the cancellation of Cadet World Championships. These matters have been resolved as per past Club advice. Notwithstanding, this highlights the vital importance of a positive, friendly and supportive culture throughout the Club.

Whilst this is concerning for the future of our Club, the 30% expansion in Full and Sailing Family memberships where, for an additional 50% fee, memberships in the Full, Young Full and Sailing categories can include any children up to 21, or 25

if in full time study, and grandchildren up to 21 years of age with equal access to our Club. This initiative is designed to provide pathway into sailing for children and grandchildren and is expected to assist a rebuilding of the junior division. This membership model is now being copied by other clubs around the bay in recognition of its merits.

As our membership ages, we have an increasing number of Members who have been contributing with subscriptions and service to the Club for 50 years or more. There is a lack of clarity around the rules qualifying Members in attaining the status of Life Membership and this has prompted a short term pause on appointing Members into this division of membership. There is a need to reward Members who have been loyal with payments over 50 years, or front-load 50 years of membership payments in advance, yet acknowledge that women have not yet been eligible for membership for 50 years, and still distinguish the extraordinary contributions that some Members make to the Club that deserve to be recognised with honour. The details are under development, and we expect to bring forward proposed changes to Members in coming months for a vote to update these rules at the next half yearly general meeting. These rule changes aim to not leave anyone behind.

The Membership Committee and office staff have worked hard with accurately and timely reporting of membership movements and especially following up and resolving issues with nonfinancial Members. Many Members now opt to have their fees paid by direct debit monthly that saves a large administrative burden for the office. This benefits the Club as well as the Members in being able to better manage finances throughout the year.

Despite the disruption of lockdown and density restrictions, we held a very successful "New Members" event that had engaging personal reflections from some older and more recent Members on their journey in the Club and engagement with Club sailing and volunteer activities. We also set up information desks at

events like the "Doggy Day Out" and "Discover Sailing Day" when a high number of visitors attended the Club with many taking up Social Memberships. We continue to seek and identify opportunities to showcase our facilities and promote the benefits of membership.

The success of these open days is only possible thanks to the generous assistance of our volunteers. We greatly appreciate your valuable contribution and we could not do this without you.

After my 35 years of membership, I have come to know many of the senior statespersons in the Club and this year it was my personal pleasure was to make a presentation on COVID to the "21 Club" dinner for Members of 21 or more years. In my professional role as Professor of Virology at the University of Melbourne and Theme leader for Viral Infectious Diseases at the Doherty Institute, I have been deeply engaged in development of both successful and unsuccessful vaccines against many troubling viruses. I was able to explain how the new COVID vaccines did not come out of nowhere, but instead stand on the shoulders 20 years of painstaking developments that all coincided at the right time to make the new generation mRNA and the AZ vectored-vaccine we have available to us now for COVID. In my opinion these vaccines are remarkably safe, especially with a now deeper understanding of how to prevent and treat occurrences of the rare side effects. In the same way we suddenly have a soft sailed 75-footer flying at close to 50 knots in the America's Cup, technology has delivered us perhaps the most effective and safest vaccines that have ever been made. Attaining a high rate of vaccination of our membership is our way back to normal operations into the future. However, it is still unclear if future legislation will demand vaccination for participation in social and sporting activities that we conduct at RYCV. It is important for the health and safety of you and your fellow Members that you take the opportunity to get the COVID vaccine jabs that are now available as soon as possible.

Membership

I thank our Membership team; Susan Webber, Karen Moore, Leonie Gunther, Nola Anderson, Sam Sulley and Andrew King, and offer them my sincere gratitude for their continued commitment. The Membership Committee is especially grateful to Melissa Wisbey for her hard work and dedication to her administrative role and to our General Manager, Michael Neumann, for his continued support and expertise throughout the year.

Members who feel they would make a positive contribution to the MC are strongly encouraged to nominate themselves and become part of a team who are committed to the success of RYCV.

It was another difficult year to manage the Club financial outcomes, but despite our best efforts the year end resulted with a small operating deficit of \$45,537.

The continued impacts of COVID restrictions caused significant disruption across most of our operating areas, and in particular our ability to maximise our revenue generation with our Food and Beverage area.

We were able to maximise our Government support for our operations in the earlier part of the year, with a total of \$185,000 in grants and subsidies from both our Federal and State Governments.

We also enjoyed Rent Relief from Parks Victoria for the 2nd half of 2020 year.

Whilst our operating position has resulted in a small deficit, we have continued to make use of excess cash in operating accounts to make additional loan repayments to reduce our interest on the loan; in May 2020 our account stood at \$497K with both our regular payments and additional contributions at May 2021 the account stood at \$167K.

I would like to also thank our Members for their ongoing support of the Club during these difficult times. Without your support we would have faced significant disruption to our Club and its strategic direction.

I would like to thank both Gary and Jenny for their effects of the period and continued support of the Club.

Note 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

Financial Reporting Framework

The financial report covers Royal Yacht Club of Victoria Inc. as an individual entity. Royal Yacht Club of Victoria Inc. is an association incorporated in Victoria under the Association Incorporations Reform Act 2012 (Vic).

The financial report is a general purpose financial report which has been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements of the Australian Accounting Standards Board (AASB) and the Associations Incorporation Reform Act 2012 (Vic). Royal Yacht Club of Victoria Inc. is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards. Material accounting policies adopted in the preparation of this financial report are presented below and have been consistently applied unless otherwise stated.

The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. The amount presented in the financial statements have been rounded to the nearest dollar.

(a) Inventories

Inventories are measured at the lower of cost and net realisable value. Costs are assigned on a first-in first-out basis.

(b) Property, Plant and Equipment

Property, plant and equipment is stated at cost less accumulated depreciation and any impairment in value.

Depreciation is calculated on a straight-line basis over the estimated useful life of the asset as follows:

Plant and equipment - over 2 to 15 years

The depreciation rates used for each class of depreciable asset are:

Club house building	2-20%
Hardstand and carpark areas	2-25%
Lockers & sundry	10%
Marina	3.34-33%
Cadet area	10%
Club boats	10-20%

Furniture & equipment	5-33%
Computer equipment	10-33%

The carrying amount of fixed assets is reviewed annually by the Committee to ensure it is not in excess of the recoverable amount of those assets. The recoverable amount is assessed as the higher of fair value less costs to sell or its value in use.

The Committee have reviewed the effective life of expenditure incurred in respect of the new Floating Marina project. Due to financial constraints, it is considered this project may not proceed in its original concept and is likely to undergo a phased implementation over a longer term. In view of this development, the Committee have adopted an accelerated rate of depreciation on the existing pile marina (20% straight line per annum) commencing with the 2017 year. Similarly, the Committee has also reviewed the effective life of expenditure for the new Western Hardstand area and have resolved to adopt a depreciation rate of 5% (straight line per annum) commencing with the 2017 year.

(c) Cash

For the purposes of the Statement of Cash Flows, cash includes cash on hand, at banks and on deposit net of bank overdrafts.

(d) Employment Entitlements

Provision is made for benefits accruing to employees, in respect of wages and salaries, annual leave, long service leave and other employee benefits when it is probable that settlement will be required and they are capable of being measured reliably.

Wages and salaries, annual leave, long service leave and other employee benefits expected to be settled within 12 months, are measured at their nominal values using the remuneration rate expected to apply at the time of settlement.

Long service leave and other employee benefits which are not expected to be settled within 12 months are measured as the present value of the estimated future cash outflows to be made by the entity in respect of services provided by employees up to the reporting date.

Superannuation Guarantee Charge

The Club pays the Superannuation Guarantee Charge (SGC) to superannuation schemes as required under applicable legislation.

(e) Income Tax

The Club is exempt from Income Tax.

(f) Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Club and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

Revenue from sale of goods and services is recognised at the point of delivery as this corresponds to the transfer of significant risks and rewards of ownership of the goods and the cessation of all involvement in those goods.

Revenue from the provision of membership subscriptions is recognised on a straight line basis over the financial year.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets, is the rate inherent in the instrument.

Other revenue is recognised when the right to receive the revenue has been established.

Revenue from contracts with customers

The core principle of AASB 15 is that revenue is recognised on a basis that reflects the transfer of promised goods or services to customers at an amount that reflects the consideration the Club expects to receive in exchange for those goods or services. Revenue is recognised by applying a five-step model as follows:

- 1. Identify the contract with the customer
- 2. Identify the performance obligations
- 3. Determine the transaction price
- 4. Allocate the transaction price to the performance obligations
- 5. Recognise revenue as and when control of the performance obligations is transferred

Notes to the Financial Statements For The Year Ended 31 May 2021

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Con't)

Specific revenue streams

The revenue recognition policies for the principal revenue streams of the Club are:

Sales of Goods

Revenue from sale of goods is recognised when the goods are physically transferred to the customer. Member subscriptions, merchandise, sponsorship and advertising

Income from these sources is recognised when the income is earned which is usually when the service is performed.

(g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of expense. Receivables and payables in the Statement of Financial Position are shown inclusive of GST.

(h) Impairment

At the end of each reporting period, the Club assesses whether there is any indication that an asset may be impaired. The assessment will include considering external sources of information and internal sources of information. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, to the asset's carrying amount. Any excess in the asset's carrying amount over its recoverable amount is recognised immediately in profit or loss, unless the asset is carried at a revalued amount. Any impairment loss of a revalued asset is treated as a revaluation decrease.

For an asset that does not generate largely independent cash inflows, the recoverable amount is determined for the cash-generating unit to which the asset belongs.

(i) Leases

The Club as a lessee

For any new contracts entered on or after 1 January 2019, the Club considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an asset (the underlying asset) for a period in exchange for consideration'. To apply this definition the Club assesses whether the contract meets three key evaluations which are whether:

- The contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Club
- The Club has the right to obtain substantially all the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract
- The Club has the right to direct the use of the identified asset throughout the period of use. The Club
 assesses whether it has the right to direct 'how and for what purpose' the asset is used throughout
 the period of use.

Measurement and recognition of leases as a lessee

At lease commencement date, the Club recognises a right-of-use asset and a lease liability on the balance sheet. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Club, an estimate of any costs to dismantle and remove the asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any incentives received).

The Club depreciates the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. The Club also assesses the right-of-use asset for impairment when such indicators exist.

At the commencement date, the Club measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease if that rate is readily available or the Club's incremental borrowing rate.

Notes to the Financial Statements For The Year Ended 31 May 2021

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Con't)

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in substance fixed), variable payments based on an index or rate, amounts expected to be payable under a residual value guarantee and payments arising from options reasonably certain to be exercised.

Subsequent to initial measurement, the liability will be reduced for payments made and increased for interest. It is remeasured to reflect any reassessment or modification, or if there are changes in insubstance fixed payments.

When the lease liability is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit and loss if the right-of-use asset is already reduced to zero.

The Club's leasing activities and how these are accounted for

The Club leases the land and marina seabed at 120 Nelson Place Williamstown Vic, which expires in 2080.

The lease agreement does not impose any covenants other than the security interests in the leased assets that are held by the lessor. Leased assets are used as security for borrowing purposes.

Until the 2019 financial year, leases of property, plant and equipment were classified as either finance leases or operating leases, see notes for details. From 1 July 2019, leases are recognised as a right-of-use asset and a corresponding liability at the date at which the leased asset is available for use by the Club.

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any incentives receivable
- variable lease payments that are based on an index or a rate, initially measured using the index or rate as at the commencement date
- amounts expected to be payable by the Club under residual value guarantees
- the exercise price of a purchase option if the Club is reasonably certain to exercise that option
- lease payments to be made under reasonably certain extension options are also included in the measurement of the liability.

Lease payments are discounted using the interest rate implicit in the lease. If that rate cannot be readily determined, which is generally the case for leases in the Club, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset or similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions.

To determine the incremental borrowing rate, the Club:

- where possible, uses recent third-party financing received by the individual lessee as a starting point, adjusted to reflect changes in financing conditions since third party financing was received
- uses a build-up approach that starts with a risk-free interest rate adjusted for credit risk for leases, which
 does not have recent third-party financing, and
- make adjustments specific to the lease, e.g. term, country, currency and security

The Club is exposed to potential future increases in variable lease payments based on an index or rate, which are not included in the lease liability until they take effect. When adjustments to lease payments based on an index or rate take effect, the lease liability is reassessed and adjusted against the right-of-use asset.

Lease payments are allocated between principal and finance cost. The finance cost is charged to profit or loss over the lease period to produce a constant periodic rate of interest on the remaining balance of the liability for each year.

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liability
- any lease payments made at or before the commencement date less any lease incentives received
- any initial direct costs, and restoration costs.

There were no contingent liabilities at 31 May 2021 that may become payable by the Royal Yacht Club of Victoria (Incorporated).

NOTE 20: FLOATING MARINA DEVELOPMENT

The Club is currently finalising a proposal for members to replace the current marina with a floating marina, this includes an expansion to the current number of berths and improved facilities for club members. It is proposed the funding for this project will be in the form of external finance. The Club has received prepaid voluntary payments on the part of members to assist the Club in the preliminary costs of evaluation of the project. (Refer Note 13). If members adopt the project then these prepayments will be attributed as license fees relating to the new marina. Members have the option (prior to the adoption of the project) of applying the prepaid amounts against current club membership fees. The Club is currently in discussion with Parks Victoria on the timing of any future development works. Parks Victoria are also undertaking a Surge and Wave energy study as a prerequisite to commencement of any works.

NOTE 22: SEGMENT REPORING

The Royal Yacht Club of Victoria (Incorporated) operates predominantly in one business and geographical segment, being promoting the use of all classes of sailing boats, the science of navigation and racing and provides social facilities for member of the club within Australia.

NOTE 23: GOING CONCERN

At 31 May 2021, the Club has recorded a net loss of \$45,537 (2020: profit of \$59,289) and had current liabilities that exceeded its current assets by \$394,928 (2020: \$217,024). The Club continued to be in a net asset position of \$1,672,875 as at 31 May 2021 (2020: \$1,718,412) and generated operating cash inflows of \$492,923 for the year ended 31 May 2021 (2020: operating cash inflows of \$298,158).

The current liabilities recognised in the financial statements include prepaid floating marina deposits of \$127,273 (2020: \$131,818), These deposits can be used against any future marina licence fees or can be used to offset annual membership/marina fees at the option of the member. Based on members recent use of these deposits, it is projected they will not result in immediate cash flow outlays for the Club.

Impacts from Coronavirus restrictions have resulted in continued disruption to all Club activities and have resulted in a drop in revenue from bar, food, and merchandise sales, due to closure of the clubhouse, reduction in yard activities and certain racing and training events being cancelled or postponed indefinitely. Management expects that these matters will resolve as social distancing measures are lifted.

The Australian Commonwealth Government had introduced significant financial support for businesses during the pandemic restrictions including Cash Boost stimulus support and Jobkeeper subsidies, but due to the length of the shutdown a number of the packages have been reduced or wound down.

NOTE 23: GOING CONCERN

The Victorian State Government has also introduced financial support for businesses including Payroll Tax relief which has assisted the Club in the 2021 year, but this has been scaled back compared to the 2020 year and has not met the losses suffered by the Club as a result of the forced closures.

The Club has also received a rent waiver from Parks Victoria for the period commencing June 2020 to December 2020 which has and will significantly assist the Club with the cash flow impacts of the pandemic.

The Club's ability to continue as a going concern is dependent upon the Club continuing to generate positive operating cash inflows through to the year ended 31 May 2022 and continuing to have access to the commercial loan facility extended to the Club by its financier or alternative funding arrangements, if required.

The Club's Committee of Management believe that the Club will be successful in the above matters and, accordingly have prepared the financial report on a going concern basis.

NOTE 24: SUBSEQUENT EVENTS

By late 2019, a limited number of cases of an unknown virus had been reported to the World Health Organisation. Following the subsequent spread of the virus, on 11 March 2020 the World Health Organisation declared the COVID-19 outbreak to be a pandemic.

However, as the virus is ongoing as at the date of this report, it is also considered to be a significant event continuing to occur after the reporting period. As such, Management will continue to consider the potential implications of coronavirus, which includes disruptions to the clubhouse operations and slowing of sales.

Management expects this to return to normalised levels in the short-to-medium term. However, the Coronavirus is unprecedented and as such the Club will pay close attention to the development of the situation and will continue to assess its impact on operations.

Qualified Opinion

I have audited the financial statements of Royal Yacht Club of Victoria Incorporated ("the "Club") for the year ended 31st May 2021 as set out in pages 42 to 61.

In my opinion, except for the possible effects of the matters described in the Basis for Qualified Opinion section of my report, the accompanying financial report of Royal Yacht Club of Victoria Incorporated is in accordance with the requirements of the Associations Incorporation Reform Act 2012 (Vic), including:

- i. giving a true and fair view of the Association's financial position as at 31st May 2021 and of its performance for the year then ended; and
- ii. that the financial records kept by the Association are such as to enable financial statements to be prepared in accordance with Australian Accounting Standards Reduced Disclosure Requirements.

Basis for Qualified Opinion

As this is my first year of appointment, I have not audited the opening balances as of 1 June 2020.

The Club did not conduct a stock take at year end and has no stock sheets of food and beverages on hand at the clubhouse at year end. The Club has estimated stock on hand at year end at \$25,102.

There are no audit trails or reconciliations of cash received at the clubhouse from the sale of food and beverages. The actual amounts banked have been taken as income, banked monthly. Accordingly, as the evidence available to me regarding cash received at the clubhouse was limited, my audit procedures with respect to cash received at the clubhouse had to be restricted to the amounts recorded in the financial records. I therefore am unable to express an opinion whether cash received at the clubhouse from the sale of food and beverages as recorded are complete.

I conducted my audit in accordance with Australian Auditing Standards. My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report. I am independent of the Association in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110: *Code of Ethics for Professional Accountants* (the Code) that are relevant to my audit of the financial report in Australia. I have also fulfilled my other ethical responsibilities in accordance with the Code.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my opinion.

Information Other than the Financial Report and Auditor's Report Thereon

The Committee of the Club is responsible for the other information. The other information comprises the information included in the Club's annual report for the year ended 31st May 2021 but does not include the financial report and my auditor's report thereon. My opinion on the financial report does not cover the other information and accordingly I do not express any form of assurance conclusion thereon. In connection with my audit of the financial report, my responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial report, or my knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work I have performed, I conclude that there is a material misstatement of this other information, I am required to report the fact. I have nothing to report in this regard.
