Members 'Friday night draw' – Terms, Conditions & Procedures

The Royal Yacht Club of Victoria (RYCV) operates a free entry lottery promoted to the members as the Friday Night Draw under the following terms and conditions:

1. Draw Particulars

The Draw is conducted every* Friday** night that the Clubs bar is open and announced over the RYCV PA system by the Promotion Host (the RYCV Chair of the House & Social Committee or their appointed delegate).

The Draw commences at \$500 and increases \$50 each week that it is not claimed, until it reaches a value of \$1500. The Draw will then remain at this figure each draw until claimed. Upon the Draw not being claimed at \$1500 a second Draw will commence the following week as per the terms of the first Draw, to run concurrently with the first Draw. The first Draw will be announced not prior to 1900 hours and as close as possible to this time. The second Draw will be announced not prior to 1930 hours and as close as possible to this time. Should both Draws be unclaimed at \$1500, a third Draw will commence as per the terms of the second Draw, the third Draw will be announced not prior to 2000 hours and as close as possible to this time.

In the case that multiple Draws are being ran concurrently and should the first or second Draw be claimed, the following draw will move into this time slot, I.E. if there are three consecutive Draws being ran and the first Draw is claimed, then the following week the second Draw moves to 1900 hours, and the third Draw moves to 1930 hours.

In the case that all three Draws, be unclaimed at \$1500 the first Draw is redrawn from 2015 hours every 5 minutes until the draw is claimed.

- *The draw may have a period of absence after Christmas until mid-late January.
- **The draw may take place the day prior should the bar be closed due to a public holiday etc. A formal notice will be published in the weekly eNews should the day be brought forwards.

2. Eligibility Criteria

- **2.1** To be eligible for the Draw a person must:
 - Be a financial RYCV member of the following categories; Full, Young Full, Full Family, Sailing, Sailing, Sailing, Social, Junior, or Country Member
 - Be a RYCV member of the following categories; Honorary Life & Life Member
 - Be in attendance within the confines of the RYCV licensed premises when the Draw is announced and
 - Be able to announce their attendance within the licensed premises to the Promotion Host within 60 seconds.

Note: A member who is already in attendance at the licensed venue but has momentarily stepped out of the licensed premises for the purpose visiting the amenities will be considered eligible for the draw if they meet all other eligibility criteria.





2.2 Persons Ineligible for the Draw:

- Persons who are not RYCV financial members, including persons whose recent application for membership has not yet been ratified by the General Committee
- A financial member within the RYCV site not attending at the licensed premises when the Draw is announced
- Nominated Family Members listed as 'Associates'
- A Club Member that is either temporarily or permanently employed by RYCV
- Members of the following categories; Non-Active, Honorary, Suspended, Special, Day (SailPass) and Corporate

3. Process to select the weekly winning Draw number/s

The Draw number/s will be selected randomly through drawing a number out of a container. All eligible financial members shall be included in the Draw number selection.

The Promotion Host shall find a random willing person in attendance to draw a number from the container. The Promotion Host with the person that drew the number will verify together if the drawn number is listed on the list of Financial Members list provided by the Financial Controller, the list will have all financial Members up until 1200 hours on the day of the draw. If the number drawn is not listed a redraw will immediately occur.

If a second or third Draw is being conducted, the Promotion Host will supervise consecutive Draws as required.

The Promotion Host will record the following details in the Badge Draw register;

- Their name
- Drawn member name/s and member no/s.
- · Persons name that drew the number
- Whether the draw was claimed

The Members name drawn is published in the next RYCV weekly eNews following each Draw and may be displayed on social media in conjunction with promoting the Club's entertainment.

4. Claiming the Draw prize money

Upon completion of the draw the successful Badge Draw winner and the Promotion Host are to present at the bar and verify their identity with their membership card and photo ID to claim their prize. The winner will receive a cash payout from the bar or can opt to have their winnings deposited by EFT transfer the following Tuesday upon provision of their bank account details. All winners opting for cash must sign the Badge Draw register to confirm receipt of their prize winnings.

If the winning member is under 18 years of age the prize must be claimed in accompany of a parent or guardian.

5. Complaint Process

The Promotion Host's Badge Draw winner decision is final, and no correspondence will be entered into. Members who wish to raise a complaint regarding the Badge Draw procedures or the operation of these procedures, however, are invited to put their concerns in writing to the General Manager or Commodore. The General Committee is required to consider the correspondence at the next scheduled Management Committee meeting and respond within 14 days of that meeting.

6. Legality

This lottery is conducted in accordance with the Victorian Gambling and Casino Control Commission 'Trade Promotion Lotteries'
