



From The Commodore

Congratulations to all our Members who participated in the 2021-22 Sailing Season. This year has been our first full season since the 2019 season. With the pandemic and lockdowns disappearing from view in the rear vision mirror. the sailing program resumed back to normal with only some minor disruptions and a couple of events not being sailed. Every weekend had at least one sailing event or race on. From the start of the year, we had some great performances from ocean racing to the Club aggregate series. Notable performers were Faster Forward (Matt Fahey), Vertigo (Tim Olding) and Rozinante II (Andrew Middleton) all taking firsts across various races during the season. In Port Phillip, the double hand series was won by Affirmative Action with Executive Decision picking up second.

In OTB, Louis Schofield pulled off a very respectable sixth in his first WASZP nationals. RYCV was host to the 14 State Titles and as the Club hosting the Victoria Youth Championships, RYCV was able to put together a successful event with competitors from all states around the country competing for selection in the national youth team. After so much disruption, we hope to build further on the success we have had as we further transition to a more volunteer based Club.

2021 Club Racing Achievements

Results for RYCV sailors are as follows: Oasis skipped by Paul O'Driscoll won the Commodores Trophy and the Elwood Huon Trophy was won by Laurelle normally skippered by Ray Borrett.

The Phoenix Trophy went to John Robb and crew on *Footloose*.

Single handed racing proved to be very strong this year and the Black Bottle Trophy was taken out by Craig Black on *Drambuie*.

Sunday racing was also well patronised with *Silver Cloud* skippered by Steve Standen winning the Tripe and Onion Series while *Shore Thing*, Robin Worland and crew, won the Steak and Mushrooms for the second year in a row.

In twilight racing, The Bill Hales Trophy (Div1 PHS) went to the team on *GNet* skippered by Peter Layton.

The Andrew Bell Trophy (Div1 AMS) was won by Dan Morrow and crew on *Affirmative Action* for the second year in a row.

The Essendon Trophy (Overall winner of the Wednesday night twilight series) went to Paul Cannon on *Redback*.

The one design trophy Alwyn Hill was won by YW Diamond *Redback* well done to Robert Hick and Paul Cannon.

Sailing Committee

During the latter part of the season our Club hosted three high profile OTB regattas: *Musto Optimists State Titles, The Youth Sailing State Championships* and *14 State Titles.*

Lipton Cup Regatta was unfortunately cancelled this season. Planning is underway for running this important event in November 2022.

This year, our Club has moved to a volunteer-based model which will continue to provide **a high standard of race management** for a range of sailing events and to further our strategic objective to enhance our reputation for hosting world-class international, national and state events. Our race committee undergoes regular training, accreditation and re-accreditation courses. Women in race management is also a key part of our strategic plan and this season we were able to secure funding for further training for women only. In addition to this, Sailing Committee has setup training sessions on Sunday afternoon for anyone who would like to get involved in race management.

Port Phillip Women's Championship Series We hosted race 3 and 4 of the Port Phillip Women's Championship (Val Hodge Trophy). Our Club race officer Amanda Rawstron oversaw the race management side while Cath Beaufort and her crew on *Up 'n Go* won the Val Hodge Trophy.

Australian Women's Keelboat Regatta was run on the 11-13 June. RYCV had three entries: *Duxelle* skippered by Catherine North, *Vertigo* Skippered by Clare Olding and *Up 'n Go* skippered by Cath Beaufort.

Up 'n Go was 1st overall in the S80 One design division.

Vertigo came 3rd in division one AMS and 2nd in Division 1 EHC.

And finally, but not least, my thanks go to the members of the Sailing Committee, OTB Committee and Cadet Worlds Organising Committee. Thanks also to our hardworking team of Staff - Michael, Andy Ian, Melissa, Camilla, Gary and Jenny. You have helped bring the Club



out of lockdown mode and into full operational mode.

Most importantly, I wish to thank all of our amazing volunteers who contribute to our on-shore and offshore activities - without you we would not be able to have such a great time out there on the water. There is a core of volunteers who turn up every week and for every regatta. Thank you to Amanda Rawstron, Steve Standen, Guy Schofield, Ryan Grieve, Wanda English, Ross Anderson and Duncan Rae.

This has been our first full racing season in a couple of years and on behalf of the Sailing Committee, I wish to acknowledge some of the great work of our volunteers and to Andy Warner (Sailing Manager) who has been able to fill the volunteer gaps. Well done everybody and let's continue and build on this into next season.

Property and Facilities

Committee

The committee has been unchanged since the last AGM. As of now, the Committee has the following members:

After more than 25 years of continuous volunteering, Rod Alsop has elected to step down as P&F Committee secretary. His contribution to the Club has been substantial and highly appreciated. We wish Rod well as he pursues other volunteering opportunities outside the Club including as President of his Probus Club.

Yard Personnel And Operations

The yard and marina continue to operate under the competent management of Max Leonard and his team. In the last 6 months, we have seen the departure of Ben and Luke. A careful search for good candidates followed and we are pleased to say that the yard is now getting back up to strength. This includes the addition of Glen Chappell who is a qualified carpenter and Steve Westlake who has substantial experience in the marine industry. Glen will spend a large part of his time maintaining the marina and other parts of the Club as well as helping out in the yard when needed. This should reduce our outgoings to trades for general Club maintenance. Steve is currently casual and will be full time in the yard as we move towards the summer peak.

Hardstand and Waterfront

The design work for the new travel lift piers is almost complete. In parallel, we are starting to pull together the documentation required to issue tenders and manage the project. It is our intention to appoint a professional, independent project superintendent to sit between the contractor and the Club. This is standard practice in the construction industry to ensure the terms of the contract are met by all parties and discrepancies

are handled in a professional way. Some remediation of the northern face of the hardstand may also be undertaken to ensure the rock fill contained by the gabion bags remains stable.

Marina

Marina occupancy continues to be strong at 91%, up from 82% at the same time last year. It is pleasing to see several new yachts enter the Club most of whom are active. We only have 1 pen that is unusable due to a failed pile. It is not economic to replace each pile as it fails, and we are undertaking an audit later in the year to detect piles that are nearing the end of their service life and organise another batch of piles to be replaced.

As mentioned at the last half year General Meeting, we continue to look at options for replacing the marina. Historically, this has focused on complete removal and replacement with a floating structure behind a full depth sea wall. This has proven to be prohibitively expensive, and we have now begun to explore options to protect our existing marina prior to its ultimate replacement. This includes collaborating with other clubs in Hobsons Bay to see if there is a possibility for a common solution or at least a common attenuation technology.

The option currently being investigated is a floating wave attenuation structure which is far cheaper than a fixed concrete wall but will not provide 100% wave attenuation. We intend to conduct a modest engineering study to model the expected performance under a range of weather and wave conditions to work out the degree of attenuation we can expect for each wave type. We can then assess the value for money this technology would provide.

Ship Surge Study

The Government funded study of ship and boat induced wash has been completed. Data was presented to the Hobsons Bay stakeholders earlier this year. Although the data collection phase of this project was comprehensive, the analysis phase was less impressive. No clear conclusions could be derived from the data as presented. We are trying to get a copy of the raw data to see if we

can glean anything from it to feed into our wave attenuation study.

Shiplift Hole Remediation

The ship lift hole has been free standing for the last 6 months with no signs of movement or concrete stress. We continue to monitor it each month and planning for the installation of whaling is well under way. We hope to have it in a useable condition by the start of the summer sailing season.

Capital Works Planning

As reported last year, the Club faces many demands on its funds to maintain and improve the Club facilities. From this report, you can see that we continue to prioritise investments and address near-term maintenance issues to ensure all our key facilities are serviceable, as well as plan for the future. The priority list has not changed much from last year. Based on what we know right now, we believe the order of priority is:

- Complete the rehabilitation of the ship lift
- hole
- Complete the travel lift pier and machine replacement project
- Investigate wave attenuation options for the existing marina
- Continue to investigate options for replacing the existing marina
- Build new launching ramps and increase casual berthing along our waterfront
- Build new lockers and contractor workshops

In Summary

We have worked hard over the last 12 months to start addressing some of the big issues the Club faces on the infrastructure front. The work will continue, and we hope that soon there will be tangible evidence of the hard work the staff and volunteers on the P&F committee have done. We wish our Members all the best for the 2022/23 season and hope that that you continue to enjoy all our wonderful Club has to offer.

Overview of House and Social for 2021- 22

Once again House and Social experienced a Covid-19 interrupted 12 months. Fortunately, over the past 6 months it looks like most of the restrictions are behind us and Members can continue to enjoy the benefits the Club has to offer.

With the significant increase in membership, numbers around the Club have steadily grown, not just in sailing but also with an array of events the Club continues to host.

Food and Beverage Services

Our new Food and Beverage Operations Manager Simone (Kienc) has brought a new direction to the Club's F&B operations which includes great food by our Chef Harry and fantastic service from our very professional wait and bar staff. Simone also knows how to entice corporate customers to the Club, especially during the down periods.

Financial Outcomes

Hospitality services has been the hardest hit industry during the Covid period and beyond, from continuous lockdowns, staff shortages, supply/price issues, higher wage pressures and so on. Unfortunately, the Club has had to pass on some of these increases to Members to remain viable. Over the past 6 months with restrictions easing, we have started to show a positive bottomline. This will auger well with future activities and function focus and new Members utilising the Club areas and F&B.

Facilities

At long last, the bathroom, toilets and changerooms are being renovated to bring the Club's facilities into the 21st century. Charlie Salter and his team are doing an outstanding job designing and project managing the work on site. Charlie and Michael Neumann engaged local builder Portside Construction (Luke Aaron) to undertake the work – Luke's skills and reputation will be reflected in a high-quality outcome. It was also agreed that with all the work going on around the main office area, plus significant termite damage, it was time to upgrade this area as well.

The construction works that are occurring in the clubhouse are due to be completed well in advance to the Cadet Worlds in December/January - hence showing off our Club in the best light on the world stage.

Archives

Ann Goodwin and her committee are working feverishly on many fronts. With the renovations happening, all of the archives have been packed up in the library and office areas, sorted, catalogued, and will eventually be put back. On another front, the Club will be celebrating 170 years since inception in 2023, the oldest yacht Club in Australia. Ann is looking for help to ensure we have our history detailed as part of this event and to make this happen, please reach out to her.

Events

H&S committee are now starting to get back to regularly putting on events for the Club. Over the past 6 months it has been catch up from all the previous events that were postponed while also squeezing in sailing events.

House and Social Committee

The other good news is that Simone and her team are very skilled at ensuring that we can provide a high standard of catering to compliment the event, the recent Mother's Day lunch was a huge success with many compliments to the Chef.

What is planned for 2022-23

The focus of the next year will be to build on our H&S activities that are aligned with Members expectations and sailing events and regattas. There are several key sailing events that will be targeted including the Lipton Cup Regatta and the Cadets Worlds. In concert with the Functions Manager and staff, we intend to have an action-packed year full of activities to get involved in.

Next year will also see the development of the RYCV Diversity and Inclusion Policy that will be developed as a sub-committee within H&S. Archives

The main achievement from the Archives Committee during the lockdowns of 2021 was the production of the book 'Cast Your Eyes Astern' about the Club history. The book expands on the Club highlights identified over 168 years and presented on the Timeline History Wall in 2019. A print run of 200 books was made with production costs underwritten by the Archives budget supported by General Committee. As author and researcher for the project, my sincere thanks go to graphic designer and collaborator, Julie Neyland. Thanks go to Commodore Doug Shields, Past Commodore John Duffin, Treasurer Warwick Norman, General Manager Michael Neumann and the RYCV General Committee Members who have supported this history project since 2018.

The book launch was held on Saturday 4th December 2021 with over 40 people attending (almost reaching the attendance limit for indoor meetings at that time). During launch proceedings, three Members of the Archives Committee, each with ten years of volunteer service to Archives, were presented with copies of the book. They were Lindsay Butler, Dr. Bernard Case and David Robbie. Approximately 80 copies of the book had been sold by mid-December. Book sales continue slowly.

Late in April 2022 when the clubhouse was being prepared for renovations, Members of the Archives Committee, assisted by other volunteers, moved all the books from the Club library to the Archive storage container. The storage container is full to capacity with boxes of books on every available shelf or horizontal storage space, even the floor. The storage container has also safely housed some the oldest Club trophies since 2109 and these were released from their bubble wrap in readiness for the 2022 Club presentation night. Theses trophies included the Lord Brassey silver tea set and the Lord Forster Cups.


A donation to the Archive collection this year was received from the Estate of Past Commodore Graeme West with photos and documents relating to the 1968 visit by Alec Rose with his yacht *Lively Lady* and the clubhouse fire in 1970. A request for information about a Past Commodore was received from the family of Charles G. Millar. Mr. Millar was Commodore for VYC 1881-1883 and

RYCV 1894-1895. A painting of Mr. Millar's yacht 'Red Gauntlet' has been on display on the Club dining wall.

The Archives Committee is hopeful that a more salubrious container will become available in the near future for keeping the Club Archives and artifacts. With the completion of the Clubhouse renovation, we are excited that another trophy cabinet will be available to display the Club's oldest trophies. It is worthy to note that more than 165 years ago in 1856, the yacht club name was changed from the Port Phillip Yacht Club to the Victoria Yacht Club. For the nationwide Heritage Month to be held during April/May 2023, the Archives Committee is planning to celebrate the Royals' 170 years 'birthday' with various events.

The Cadets were lucky enough for theirs to proceed in Largs Bay, Adelaide over Christmas however it was the smallest Cadet Nationals in many years with only 31 competitors. We had two boats in *Pepsea* and *Consecutive* make the trip west.

Membership

Our RYCV Members continued to show their appreciation and loyalty to the Club over the past year with strong numbers of renewals despite the ongoing impact on many aspects of life caused by the COVID pandemic. Sailing and social events restarted after COVID vaccination rates met government supported high level targets, allowing Members to again enjoy Club benefits. Crucially, we were able to retain our staff and offer full service while meeting the ongoing changes to the Victorian government health department restrictions that progressively eased.

Membership fees returned to their full level for this past season after Members benefited from a 25% reduction in membership fees in the 2020 – 2021 season that was passed back from pandemic financial relief received from the Federal government programs. Inevitably we lost some Members, but these were almost entirely in the social category. Nevertheless, we witnessed an even larger uptake of new social memberships that has swelled the numbers in this Member category. Our outdoor dining offerings and weekend live entertainment in the warmer months are proving an attractive prospect drawing in new social Members. Some of our sailing Members converted to social memberships rather than resign their association with the Club. We appreciate that this is an attractive choice for older Members aging out of sailing activities. Overall, we achieved a healthy 9% rise in membership to a total of 1082, that was close to the remarkable 12.6% increase from the previous year. Social memberships increased by 34% over the year yet are only 32% of our total voting membership. The sailing divisions dominate making up 63% of all our Members. We also achieved the remarkable result of 100% full-financial membership during the year.

The mainstay of our Club are the Members who participate in Club sailing activities. These Members have been loyal and strongly supportive of activities at the Club, despite the uncertainties of COVID adding to the ever-present vagaries of the weather for sailing. Our Full, Family and Sailing Members continue to support volunteer roles on committees, on-water and off-water roles for junior and keelboat sailing events. The community spirit engendered by working together to sail safely and with good sportsmanship has built a noticeable healthy culture at the Club.

The success of social memberships has been built on our dining and bar operations and the Club's facilities for outdoor dining on the deck and the lawn. The improved quality and value for money of the food and beverage offering, together with a revamp of the dining facilities and options, outweighed the inconvenience imposed by the public health requirements for managing guest registrations and social distancing. This has been a great achievement given the circumstances.

Our Social Members are a precious asset for the Club and the Membership Committee are working with the Sailing Committee to explore ways Social Members can begin to engage in sailing. A steadily increasing number of Social Members have upgraded to sailing memberships, despite limited on-water activity over the past season. The Sail Training Academy, on-water volunteering and the SailPass scheme have all assisted Social Members in making this transition. But ultimately it is the welcome and encouragement new sailors get from boat owners and their crews that is the most important factor. We thank all those who have helped in this regard. We will continue to look for more avenues to introduce Social Members to sailing.

One of the objectives for the Membership Committee is to encourage a reduction in the average age of our membership. Younger Members are needed to ensure the ongoing longevity and future prosperity of our Club. The average ages of Social and Sailing Members are now about the same (55.8/55.6vo) and the average age of our total membership has held steady this year at 55.6yo. However, the collection of this information is hampered by not having a record of the age of every Member. We continue to look for Junior and Junior Family Members to bring the age levels down, but at the same time our more Senior Members who continue to advance in age are retaining their memberships. So overall, we are achieving our objectives on Member ages.

The rules for Life membership categories were clarified by a vote on new definitions at this year's half yearly general meeting. Since then, there were no written applications for Honorary Life membership. However, we have pleasure in announcing that we have four new Life Members achieving 50 years of membership in the last reporting year:

We are sad to record the passing of Members Peter Rowsthorn (Past Commodore and at 50 years of membership), Douglas Anderson, Terry O'Hare and Gregory John Raymond. We thank each of them for their service to the Club and the happy memories of their active participation.

The Membership Committee and office staff have worked hard with accurately and timely reporting of membership movements and especially following up and resolving issues with nonfinancial Members. Many Members are now opting to have their fees paid by direct debit monthly that saves a large administrative burden for the office and Members benefit from distributing the costs throughout the year.

We once again held a very successful "New Members" event that included engaging personal reflections on pathways into sailing, including from some transitioning from Social Membership to sailing and volunteer activities in the Club. Special event days attended by visiting guests have resulted in a high uptake of Social Memberships. We continue to seek and identify opportunities to showcase our facilities and promote the benefits of membership. The success of these open days is only possible thanks to the generous assistance of our volunteers. We greatly appreciate your valuable contribution and we could not do this without you.

I thank our Membership team; Susan Webber, Karen Moore, Leonie Gunther, Nola Anderson, Sam Sully and Rear Commodore Sailing Andrew King, and offer them my sincere gratitude for their continued commitment. The Membership Committee is especially grateful to Melissa Wisbey for her hard work and dedication to her administrative role and to our General Manager, Michael Neumann, for his continued support and expertise throughout the year. With the retirement of Leonie Gunther and Nola Anderson we are actively seeking new committee Members to become part of a team who are committed to the success of RYCV.

Note 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

Financial Reporting Framework

The financial report covers Royal Yacht Club of Victoria Inc. as an individual entity. Royal Yacht Club of Victoria Inc. is an association incorporated in Victoria under the Association Incorporations Reform Act 2012 (Vic).

The financial report is a general-purpose financial report which has been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements of the Australian Accounting Standards Board (AASB) and the Associations Incorporation Reform Act 2012 (Vic). Royal Yacht Club of Victoria Inc. is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards. Material accounting policies adopted in the preparation of this financial report are presented below and have been consistently applied unless otherwise stated.

The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets, and financial liabilities. The amount presented in the financial statements have been rounded to the nearest dollar.

(a) Inventories

Inventories are measured at the lower of cost and net realisable value. Costs are assigned on a first-in first-out basis.

(b) Property, Plant and Equipment

Property, plant, and equipment is stated at cost less accumulated depreciation and any impairment in value

Depreciation is calculated on a straight-line basis over the estimated useful life of the asset as follows:

Plant and equipment - over 2 to 15 years

The depreciation rates used for each class of depreciable asset are:

The carrying amount of fixed assets is reviewed annually by the Committee to ensure it is not in excess of the recoverable amount of those assets. The recoverable amount is assessed as the higher of fair value less costs to sell or its value in use.

The Committee have reviewed the effective life of expenditure incurred in respect of the new Floating Marina project. Due to financial constraints, it is considered this project may not proceed in its original concept and is likely to undergo a phased implementation over a longer term. In view of this development, the Committee have adopted an accelerated rate of depreciation on the existing pile marina (20% straight line per annum) commencing with the 2017 year. Similarly, the Committee has also reviewed the effective life of expenditure for the new Western Hardstand area and have resolved to adopt a depreciation rate of 5% (straight line per annum) commencing with the 2017 year.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Con't)

(c) Cash

For the purposes of the Statement of Cash Flows, cash includes cash on hand, at banks and on deposit net of bank overdrafts.

(d) Employment Entitlements

Provision is made for benefits accruing to employees, in respect of wages and salaries, annual leave, long service leave and other employee benefits when it is probable that settlement will be required, and they are capable of being measured reliably.

Wages and salaries, annual leave, long service leave and other employee benefits expected to be settled within 12 months, are measured at their nominal values using the remuneration rate expected to apply at the time of settlement.

Long service leave and other employee benefits which are not expected to be settled within 12 months are measured as the present value of the estimated future cash outflows to be made by the entity in respect of services provided by employees up to the reporting date.

Superannuation Guarantee Charge

The Club pays the Superannuation Guarantee Charge (SGC) to superannuation schemes as required under applicable legislation.

(e) Income Tax

The Club is exempt from Income Tax.

(f) Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Club and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

Revenue from sale of goods and services is recognised at the point of delivery as this corresponds to the transfer of significant risks and rewards of ownership of the goods and the cessation of all involvement in those goods.

Revenue from the provision of membership subscriptions is recognised on a straight line basis over the financial year.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets, is the rate inherent in the instrument.

Other revenue is recognised when the right to receive the revenue has been established.

Revenue from contracts with customers

The core principle of AASB 15 is that revenue is recognised on a basis that reflects the transfer of promised goods or services to customers at an amount that reflects the consideration the Club expects to receive in exchange for those goods or services. Revenue is recognised by applying a five-step model as follows:

- 1. Identify the contract with the customer
- 2. Identify the performance obligations
- 3. Determine the transaction price
- 4. Allocate the transaction price to the performance obligations
- 5. Recognise revenue as and when control of the performance obligations is transferred

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Con't)

Specific revenue streams

The revenue recognition policies for the principal revenue streams of the Club are:

Sales of Goods

Revenue from sale of goods is recognised when the goods are physically transferred to the customer.

Member subscriptions, merchandise, sponsorship and advertising

Income from these sources is recognised when the income is earned which is usually when the service is performed.

(g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of expense. Receivables and payables in the Statement of Financial Position are shown inclusive of GST.

(h) Impairment

At the end of each reporting period, the Club assesses whether there is any indication that an asset may be impaired. The assessment will include considering external sources of information and internal sources of information. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, to the asset's carrying amount. Any excess in the asset's carrying amount over its recoverable amount is recognised immediately in profit or loss unless the asset is carried at a revalued amount. Any impairment loss of a revalued asset is treated as a revaluation decrease.

For an asset that does not generate largely independent cash inflows, the recoverable amount is determined for the cash-generating unit to which the asset belongs.

(i) Leases

The Club as a lessee

For any new contracts entered on or after 1 January 2019, the Club considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an asset (the underlying asset) for a period in exchange for consideration'. To apply this definition the Club assesses whether the contract meets three key evaluations which are whether:

- The contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Club
- The Club has the right to obtain substantially all the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract
- The Club has the right to direct the use of the identified asset throughout the period of use. The Club assesses whether it has the right to direct 'how and for what purpose' the asset is used throughout the period of use.

Measurement and recognition of leases as a lessee

At lease commencement date, the Club recognises a right-of-use asset and a lease liability on the balance sheet. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Club, an estimate of any costs to dismantle and remove the asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any incentives received).

The Club depreciates the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. The Club also assesses the right-of-use asset for impairment when such indicators exist.

At the commencement date, the Club measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease if that rate is readily available or the Club's incremental borrowing rate.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Con't)

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in substance fixed), variable payments based on an index or rate, amounts expected to be payable under a residual value guarantee and payments arising from options reasonably certain to be exercised.

Subsequent to initial measurement, the liability will be reduced for payments made and increased for interest. It is remeasured to reflect any reassessment or modification, or if there are changes in insubstance fixed payments.

When the lease liability is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit and loss if the right-of-use asset is already reduced to zero.

The Club's leasing activities and how these are accounted for

The Club leases the land and marina seabed at 120 Nelson Place Williamstown Vic, which expires in 2080.

The lease agreement does not impose any covenants other than the security interests in the leased assets that are held by the lessor. Leased assets are used as security for borrowing purposes.

Until the 2019 financial year, leases of property, plant and equipment were classified as either finance leases or operating leases, see notes for details. From 1 July 2019, leases are recognised as a right-of-use asset and a corresponding liability at the date at which the leased asset is available for use by the Club.

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any incentives receivable
- variable lease payments that are based on an index or a rate, initially measured using the index or rate as at the commencement date
- amounts expected to be payable by the Club under residual value guarantees
- the exercise price of a purchase option if the Club is reasonably certain to exercise that option
- lease payments to be made under reasonably certain extension options are also included in the measurement
 of the liability.

Lease payments are discounted using the interest rate implicit in the lease. If that rate cannot be readily determined, which is generally the case for leases in the Club, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset or similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions.

To determine the incremental borrowing rate, the Club:

- where possible, uses recent third-party financing received by the individual lessee as a starting point, adjusted to reflect changes in financing conditions since third party financing was received
- uses a build-up approach that starts with a risk-free interest rate adjusted for credit risk for leases, which
 does not have recent third-party financing, and
- make adjustments specific to the lease, e.g. term, country, currency and security

The Club is exposed to potential future increases in variable lease payments based on an index or rate, which are not included in the lease liability until they take effect. When adjustments to lease payments based on an index or rate take effect, the lease liability is reassessed and adjusted against the right-of-use asset.

Lease payments are allocated between principal and finance cost. The finance cost is charged to profit or loss over the lease period to produce a constant periodic rate of interest on the remaining balance of the liability for each year.

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liability
- any lease payments made at or before the commencement date less any lease incentives received
- any initial direct costs, and restoration costs.

Right-of-use assets are generally depreciated over the shorter of the asset's useful life and the lease term on a straight-line basis. If the Club is reasonably certain to exercise a purchase option, the right-of-use asset is depreciated over the underlying asset's useful life.

NOTE 19: FLOATING MARINA DEVELOPMENT

The Club is currently finalising a proposal for members to replace the current marina with a floating marina, this includes an expansion to the current number of berths and improved facilities for club members. It is proposed the funding for this project will be in the form of external finance. The Club has received prepaid voluntary payments on the part of members to assist the Club in the preliminary costs of evaluation of the project. (Refer Note 12). If members adopt the project, then these prepayments will be attributed as license fees relating to the new marina. Members have the option (prior to the adoption of the project) of applying the prepaid amounts against current club membership fees. The Club is currently in discussion with Parks Victoria on the timing of any future development works. Parks Victoria are also undertaking a Surge and Wave energy study as a prerequisite to commencement of any works.

NOTE 21: SEGMENT REPORING

The Royal Yacht Club of Victoria (Incorporated) operates predominantly in one business and geographical segment, being promoting the use of all classes of sailing boats, the science of navigation and racing and provides social facilities for member of the club within Australia.

NOTE 22: GOING CONCERN

At 31 May 2022, the Club has recorded a net profit of \$164,286 (2021: loss of \$45,537) and had current liabilities that exceeded its current assets by \$375,766 (2021: \$394,928). The Club continued to be in a net asset position of \$1,837,161 as at 31 May 2022 (2021: \$1,672,875) and generated operating cash inflows of \$495,570 for the year ended 31 May 2022 (2021: operating cash inflows of \$492,723).

The current liabilities recognised in the financial statements include prepaid floating marina deposits of \$118,182 (2021: \$127,273), These deposits can be used against any future marina licence fees or can be used to offset annual membership/marina fees at the option of the member. Based on members recent use of these deposits, it is projected they will not result in immediate cash flow outlays for the Club.

Regarding the Club's lease with Parks Victoria, the Club has obtained an extension to 31 December 2022, to fulfill item 1 of 'Annexure A' 'Development Works Schedule'. The Club has submitted a proposal and is currently negotiating with Parks Victoria to vary the items noted in the aforesaid 'Annexure A". The Club's Committee of Management believe its proposal and negotiations will be successful, to ensure the lease remains valid and continues in force until the end of the lease term.

The Club's ability to continue as a going concern is dependent upon the Club continuing to generate positive operating cash inflows through to the year ended 31 May 2023, continuing to have access to the commercial loan facility extended to the Club by its financier or alternative funding arrangements, if required, and the acceptance of the lease proposal or favourable negotiations with Parks Victoria.

The Club's Committee of Management believe that the Club will be successful in the above matters and, accordingly have prepared the financial report on a going concern basis.

NOTE 23: SUBSEQUENT EVENTS

By late 2019, a limited number of cases of an unknown virus had been reported to the World Health Organisation. Following the subsequent spread of the virus, on 11 March 2020 the World Health Organisation declared the COVID-19 outbreak to be a pandemic.

However, as the virus is ongoing as at the date of this report, it is also considered to be a significant event continuing to occur after the reporting period. As such, Management will continue to consider the potential implications of coronavirus, which includes disruptions to the clubhouse operations and slowing of sales.

Management expects this to return to normalised levels in the short-to-medium term. However, the Coronavirus is unprecedented and as such the Club will pay close attention to the development of the situation and will continue to assess its impact on operations.

I have audited the financial statements of Royal Yacht Club of Victoria Incorporated ("the "Club") for the year ended 31st May 2022 as set out in pages 38 to 57.

In my opinion, except for the possible effects of the matters described in the Basis for Qualified Opinion section of my report, the accompanying financial report of Royal Yacht Club of Victoria Incorporated is in accordance with the requirements of the Associations Incorporation Reform Act 2012 (Vic), including:

- i. giving a true and fair view of the Association's financial position as at 31st May 2022 and of its performance for the year then ended; and
- ii. that the financial records kept by the Association are such as to enable financial statements to be prepared in accordance with Australian Accounting Standards Reduced Disclosure Requirements.

Basis for Qualified Opinion

The reports of takings reflecting cash and eftpos receipts from the Lightspeed PoS system do not appear to be accurate with unexplained variances. There are no audit trails or reconciliations of cash received at the clubhouse from the sale of food and beverages. The actual amounts banked have been taken as income. Accordingly, as the evidence available to me regarding income generated and banked at the clubhouse was limited, my audit procedures with respect to income received at the clubhouse had to be restricted to the amounts recorded in the financial records. I therefore am unable to express an opinion whether income received at the clubhouse from the sale of food and beverages as recorded is complete.

I conducted my audit in accordance with Australian Auditing Standards. My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report. I am independent of the Association in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110: *Code of Ethics for Professional Accountants* (the Code) that are relevant to my audit of the financial report in Australia. I have also fulfilled my other ethical responsibilities in accordance with the Code.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my opinion.

Information Other than the Financial Report and Auditor's Report Thereon

The Committee of the Club is responsible for the other information. The other information comprises the information included in the Club's annual report for the year ended 31st May 2022 but does not include the financial report and my auditor's report thereon. My opinion on the financial report does not cover the other information and accordingly I do not express any form of assurance conclusion thereon. In connection with my audit of the financial report, my responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial report, or my knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work I have performed, I conclude that there is a material misstatement of this other information, I am required to report the fact. I have nothing to report in this regard.

Responsibilities of the Committee for the Financial Report

The Committee of the Club is responsible for the preparation of the financial report that gives a true and fair view in accordance with Australian Accounting Standards and the Associations Incorporation Reform Act 2012 (Vic) and for such internal control as the Committee determines is necessary to enable the preparation of the financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the Committee is responsible for assessing the Club's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Committee either intends to liquidate the Association or to cease operations, or have no realistic alternative but to do so.

Auditor's Responsibilities for the Audit of the Financial Report

My objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.
