



# RYCV CLUB BOAT USAGE AGREEMENT

I agree: -

1. To have the boat assessed by an RYCV staff member or member of the OTB committee before and after the usage period.
  - a Assessment will be done using the Safety Culture App which will create a comprehensive record of the boats condition and will be done at the handover of boat to the club member and at the end of the usage period.
2. To report any damage as soon as possible to the RYCV office
  - a Damage reports will be made using the Safety Culture App, preferably with full descriptions and photos of the damage.
3. To maintain the boat and return it to the RYCV in similar, if not better condition at the end of the usage period.
4. To replace any items that are lost or damaged through my actions that are not covered by an insurance claim.
5. That the usage period will be for 1 season. Sailors are permitted to use the club boat for 1 season only.
6. That the allocation of the Boat may be retracted at any time by the OTB committee.
7. To undertake to compete in at least 70% of Club Race and Social Days (weather permitting) during seasonal usage period.
8. I will not hold RYCV, its Officers, Members or Staff responsible in respect to loss of life, personal injury or loss or damage to property that may be sustained by reason of their connection to the Boat.
9. That any Race Fees are an additional cost to the boat user.
10. The RYCV has arranged insurance of the Boat, including cover for Racing, however the Skipper must be a RYCV Member with a Yachting Australia Silver Card (Personal Insurance is covered by YA).
11. I understand that while the club boat is generally for my exclusive use for the whole usage period, the OTB committee may utilise the boat, if required, for training and other purposes,
12. That club boats are not to be taken away from the Club without approval from the OTB committee.
13. To use the boat only under supervised conditions.
14. That I will be responsible for any insurance excess up to a value of \$100.
