 - "Club activities" means performing or participating in any capacity in any authorised or recognised Club activity.
- The Club Rules is a contract between me and the Club. I will be bound by it and any By-Laws, regulations or policies made under it.
- 3. Warning: Club activities can be inherently dangerous. I acknowledge that I have read and understood this warning and accept the inherent risks in participating in the Club activities.
- 4. Release and Indemnity: I:
